

Non-Immigrant O

1. The application form printed and signed by the applicant. The signature must be the same as the one in the passport.
2. A recent color photograph, 3,5 x 4,5 cm. (Photocopies are not accepted). The photograph must be taken formally, white background, without wearing a hat or dark glasses and must be taken within 6 months. Informal photographs will not be accepted.
3. Original valid passport at least 6 months without any defect.
4. A copy of the passport (first page containing applicant information)
5. Different documents as follows:

In case your purpose is to go for medical treatment

- Proof of income (letter of employment and / or bank statement).
- A letter of certification from the hospital / clinic / medical center in Thailand in which your name, date and time of appointment must be specified.
- Registration of the hospital / clinic / medical center.

NOTE: For this purpose, you can apply for a tourist visa for an entry as well.

In case you are going to volunteer at an NGO / Foundation / Nonprofit Association / without receiving any salary / income / compensation

- A certification letter from such organization / foundation / association, signed by the authorized, together with a copy of the official identification of such signer.
- Proof of registration / permission of such organization / foundation / association.
- Work permit (Only for cases of visa application to go to work with the same organization / foundation / association).

NOTICE:

- In this case, if you will receive salary / income / compensation, you must apply for a visa of Non-Immigrant B (no need to submit Tor Thor 3).
- If you are accompanying the volunteer, you must also apply for a Non-Immigrant visa O.

If your purpose is to visit your spouse, child, and / or relative who has a Thai nationality

- Proof of relationship with such family member, for example, by means of a marriage certificate, and an identification copy of such family member having Thai nationality.
- Proof of transport reservation showing date of entry and departure to / from Thailand. There must be the name of the applicant in the document.
- Proof of income (letter of employment and / or bank statement).

NOTE: If you apply for a multiple entry, AGREE that you must leave Thailand and return to Mexico, Guatemala, Cuba, Belize, Nicaragua or Honduras, as appropriate, and re-enter Thailand again when necessary for 1 Year, every time it enters, it can only be 90 days.

In case your purpose is to appear before a court in court cases

- Proof of such judicial case in which your relationship with the accused / suspect / plaintiff / witness is specified.
- Proof of transport reservation showing date of entry and departure to / from Thailand. There must be the name of the applicant in the document.
- Proof of income (letter of employment and / or bank statement).
- Proof of hotel / lodging reservation in Thailand.

GENERAL NOTES:

- All applicants for Non-Immigrant visas, it is also advisable to present transport reservation and hotel / accommodation reservations even if we do not ask for them.
- Applicants who do not have a passport from Mexico, or Guatemala, Belize, Cuba, Honduras or Nicaragua, where the Royal Embassy of Thailand in Mexico has jurisdiction, must present a copy of proof of residence in Mexico (FM2 / FM3).
- If you send the documents by courier, you must send a prepaid guide that includes collection so that the passport is returned.
- INDISPENSABLE: YOU MUST bring the original proof of payment. Applicants must pay the cost of the corresponding visa in the bank account of the Embassy.

IMPORTANT:

1. Payments in Mexico: Only Scotiabank deposit forms are accepted. Interbank transfers and transfers are not accepted.

2. Payments abroad (outside Mexico), at the time of making the deposit must also pay the commission charged by the bank for the international transfer (35.53 USD, approx.).

3. Payments in GUATEMALA: TRANSFERS OF THE INDUSTRIAL BANK ARE ONLY ACCEPTED (NO JP MORGAN CHASE, NO BAC)
